ORDER CREATING SANITARY DISTRICT

A petition addressed to the Town Board of the Town of Bayfield, County of Bayfield, State of Wisconsin, and praying for the incorporation of a Town Sanitary District located entirely within the limits of said town, having been filed with the Town Clerk and on due notice a public hearing having been held on the petition in the Town Hall of the Town of Bayfield in said town on the 6th day of December, 1976, and the bond required by law having been filed and approved, and the State Board of Health and Department of Resource Development having appeared at said hearing by David W. Herrick, R.S., District Sanitarian and David C. Wahlstrom, R.S., Public Health Sanitarian, and the said Town Board having heard all persons interested in said proposal;

Now, after consideration of all objections to said proposal and reasons in favor of it, we, the said Town Board, do declare and find that said petition is signed by the requisite number of the real estate owners as provided in sub-section (1) of section 60.302, Statutes; that the proposed work is necessary and that the public health, comfort, convenience, necessity and public welfare will be promoted by the establishment of such district and that the property included in the district will be benefited by the establishment thereof.

NOW, THEREFORE, IT IS ORDERED That a Town Sanitary District be and hereby is organized for the purpose of carrying out the provisions of sections 60.30 to 60.315, inclusive, of the Wisconsin Statutes, the corporate name of which shall be Pikes Bay Sanitary District of the Town of Bayfield, and the boundaries thereof are
